If guests are brought to the 100 yard range on Public shooting days, then each guest must pay the standard range fee of \$5.00. At any other time or range the guests are not charged any fee. The Active member is responsible for the actions and safety of the invited guests at all times.**

I have been asked to again remind you that if you bring more guests than allowed or regularly bring the same guest, please have them become a member. The Annual Membership cost is cheap for what they get – about the cost of two 20 round boxes of high power rifle ammo.

**NOTICE: FUTURE RANGE CLOSING.** January 28, 2017 has been scheduled for the perimeter fence rehab. Obviously, for safety the entire range must be closed. Again, the more volunteers we have the faster it can be completed, so mark your calendars.
