GENERAL MEETING IS HELD AT THE AMERICAN LEGION POST EVERY 3RD THURSDAY AT 7:00pm, 709 E HIGHWAY 260, Payson, AZ 85541

REMINDER FIRE RESTRICTIONS IN EFFECT: When you are at the Range you are only allowed to smoke within an enclosed vehicle. Also, please be Firewise ... if you are the last person at the range, please wait 15 to 30 minutes after the last shot to ensure there is no fire.

You may have seen on the news that Tannerite was the cause of a wild fire in Utah. Your Board asked that I make you aware that you should not be using explosives *in any form* (exploding targets included) on the range.

GROUP USE OF THE RANGE:

With the fire restrictions in effect (and shooting not allowed in the forest), we are getting increased requests for groups to use the range. Forrest Switzer, our Chief RSO, has asked us to state the procedures for groups to request permission to use the range:

- Requests for Consideration of Range Group Reservations are required to be submitted for Review by the 15th of the Month Prior to the Month of Requested use.
- Requests need to be submitted via email to JJschedule@outlook.com
- Requests must be for a Specific: Date, Time, and Range (Public, Rifle, Pistol Bay), and include Official Group Name, Number and Age of Shooters.
- Completed Insurance Forms and individual Guardian or Adult Release forms are Required.
- Generally there will be a \$5 cost per shooter.
- TRSC Members are allowed to bring guests per Membership Regulations, using Non-Reserved Ranges on a First Come priority.
- Accepted Reservations are Posted Monthly in the Newsletter (possibly some Emergency Law Enforcement exceptions).

NEWSLETTER DELIVERY: For those who are getting the newsletter through the mail there is obviously a gap between when those on the Computer Email list receive it and when the mail is delivered by the post office. (Also, if you are gone part time and have your mail forwarded, the post office will not forward the newsletter because it is bulk mail.
